### COMPLETING THIS FORM:

1. THIS FORM SHOULD BE COMPLETED BY AN AFFILIATE, PRINCIPAL ENTITY, PRINCIPAL, OR KEY EMPLOYEE CURRENTLY LICENSED BY THE BOARD AND SEEKING TO RENEW A VGT-RELATED LICENSE.
2. YOU MUST MAKE ACCURATE STATEMENTS AND INCLUDE ALL MATERIAL FACTS. ANY MISREPRESENTATION, FALSIFICATION OR OMISSION OR THE FAILURE TO PROVIDE REQUESTED INFORMATION, MAY RESULT IN THE DENIAL OF YOUR REQUEST FOR THE BOARD TO USE AN ABBREVIATED PROCESS TO CONSIDER THE ISSUANCE OF A LICENSE.
3. AS PART OF THE INVESTIGATORY PROCESS, YOU MAY BE ASKED TO SUPPLY ADDITIONAL DOCUMENTS OR INFORMATION.
4. ALL ENTRIES ON THIS FORM, EXCEPT SIGNATURES, MUST BE TYPED OR PRINTED IN BLOCK LETTERING USING DARK INK. IF YOUR FORM IS NOT LEGIBLE, IT WILL NOT BE ACCEPTED.
5. IF YOU MAKE ANY MODIFICATION TO THE PRE-PRINTED QUESTIONS OR INFORMATION CONTAINED IN THIS FORM, YOUR ABBREVIATED APPLICATION WILL BE REJECTED. ONCE YOUR APPLICATION IS ACCEPTED, IT BECOMES THE PROPERTY OF THE BOARD AND WILL NOT BE RETURNED.
6. RETAIN A COMPLETED COPY OF YOUR ABBREVIATED APPLICATION PACKAGE FOR YOUR OWN RECORDS.
7. A LICENSE ISSUANCE, RENEWAL OR OTHER APPROVAL ISSUED BY THE BOARD IS A REVOCABLE PRIVILEGE. NO PERSON HOLDING A LICENSE, PERMIT, CERTIFICATION OR REGISTRATION, RENEWAL, OR OTHER APPROVAL IS DEEMED TO HAVE ANY PROPERTY RIGHTS RELATED TO THE LICENSE, PERMIT, CERTIFICATION, OR REGISTRATION.
8. WHEN THE FORM IS COMPLETED, CONTACT THE ENTERPRISE LICENSING ANALYST FOR INSTRUCTIONS TO ELECTRONICALLY SUBMIT THE APPLICATION AND FEES.

### FEES:

1. VGT APPLICATION FEE OF \$500 AND VGT LICENSE FEE OF \$500 ARE BOTH DUE WITH THE SUBMISSION OF THIS APPLICATION.
