#### 1. Certification Forms

The forms that can make up an application package for a Certification are as follows:

#### A. Certification Form

This form must be completed by an enterprise if the total dollar amount of transactions with slot machine licensee(s) or applicant(s) are or will be greater than \$500,000 within any consecutive 12-month period and if the enterprise will be providing service on the gaming floor or in a restricted area. These thresholds do not apply to enterprises filing for an Interactive or Sports Wagering Gaming Service Provider Certification. Interactive and Sports Wagering Gaming Service Provider must complete the certification package if they provide any of the services listed below:

- Data warehousing hosting services.
- Payment processing and related money-transmitting services.
- Customer identity, age verification and geo-location verification used in the conduct of interactive and mobile gaming.
- An individual or entity acting as an interactive affiliate that receives a revenue share for promoting, marketing and directing business to an online gaming site.
- Provides odds or raw data to sports wagering certificate holders or sports wagering operators that is used to conduct sports wagering.
- Provides risk management services or integrity monitoring services to sports wagering certificate holders or sports wagering operators.
- Any other person as determined by the Board.

#### B. Certification Form –Holding Company

This form must be completed by any entity that directly owns 20% or more of the voting securities of a certified gaming service provider

#### D. Pennsylvania Personal History Disclosure Form – Gaming Service Provider

This form must be completed by any individual that has a direct or indirect ownership or beneficial interest of 10% or more of the certified gaming service provider or a salesperson/employee that solicits business from, or has regular contact with, any representative of a licensee or applicant.

### 2. Application and Certification Fees

#### A. Application Fees

Application and Certification fees must be submitted with the application package. These fees will be used by the Board to process and investigate the gaming service provider applicant, the applicant's affiliated entities and qualifiers (individuals) filing forms as part of the application package.

The fees indicated are non-refundable deposits required to cover the reasonable and necessary costs of the background investigation. No additional costs or expenses related to the background investigation will be billed, unless an investigator is required to travel in overnight status or stenographic services are required. In either case, actual costs incurred by the Board shall be reimbursed by the applicant.

### 3. Application Form Instructions

As used in this form, the words "applicant" and "you" shall mean the gaming service provider completing this Certification Form.

All entries on the form must be typed or printed in block lettering. Initials and signatures must be handwritten by the person providing the information. If the answers are not legible, the application may not be accepted.

Read each question carefully prior to answering. Answer every question completely. Do not leave blank spaces. If a question does not apply to the applicant, write "**Does Not Apply**" in response to that question.

All pages of the form must be initialed by the applicant. If additional pages are required in order to answer any question, additional pages may be utilized and must be attached to the form. Be sure to indicate the number(s) of the question(s) being answered and initial each additional page.

All required documentation must be submitted at the time of filing this form. Further, pursuant to the Board's Regulations the applicant is under a continuing duty to promptly notify the Board if there is a change in the information provided to the Board.

Should you be unable to understand this form fully in English, it is your responsibility to acquire adequate means of translation. If you submit a document to the Board that is in a language other than English, you must also submit an English translation compliant with the Board's Regulations.

All notices regarding your application will be sent to the address you provide on this form. You must immediately notify the Board if you change your address.

Failure to answer any question completely and truthfully may result in denial of your application and/or revocation of your license, registration, certification or permit and may subject you to criminal penalties.

Any person who applies for and obtains a license, registration, certification or permit from the Board may be required to submit to warrantless searches when present in a licensed gaming facility pursuant to the Act.

A license, permit, certification or registration issuance, renewal or other approval issued by the Board is a revocable privilege. No person holding a license, permit, certification or registration, renewal, or other approval is deemed to have any property rights related to the license, permit, certification or registration.

Confidential information supplied to the Board or otherwise obtained shall not be revealed except in the course of the necessary administration of the Act, or upon the lawful order of a court of competent jurisdiction or, with the approval of the Attorney General, to a duly authorized law enforcement agency. An applicant, licensee, registrant, certificant or permit holder waives any liability of the Commonwealth of Pennsylvania and its instrumentalities and agents for any damages resulting from any disclosure or publication in any manner, other than a willfully unlawful disclosure or publication.

Pursuant to the Board's Regulations, once the application has been filed, applicant **may not** withdraw its application without the permission of the Board.

- 20. TO DEVELOP, IMPLEMENT, AND PROVIDE A DIVERSITY PLAN TO THE BOARD, IN ACCORDANCE WITH ITS REGULATIONS, WHICH ASSURES THAT ALL PERSONS ARE ACCORDED EQUALITY OF OPPORTUNITY IN EMPLOYMENT AND CONTRACTING BY THE GAMING SERVICE PROVIDER, ITS CONTRACTORS, SUBCONTRACTORS, ASSIGNEES, LESSEES ORAGENTS.

- 22. TO IMMEDIATELY NOTIFY THE BOARD OF ANY LITIGATION WHEREIN THE AMOUNT AT ISSUE IS \$100,000 OR GREATER AND GAMING SERVICE PROVIDER IS NAMED AS A DEFENDANT.

#### CONDITIONS 23-27 BELOW ONLY PERTAIN TO GAMING RELATED GAMING SERVICE PROVIDERS

WHEREAS, as a condition precedent to the issuance of said gaming service provider certification, Indemnitor executed a Statement of Conditions, which is incorporated herein by reference, expressly accepting certain enumerated conditions to its gaming service provider certification; and,

WHEREAS, Condition 18 of the above-referenced Statement of Conditions requires Certified Gaming Service Provider as Indemnitor to execute, a separate indemnification agreement in a form prescribed by the Board so as to indemnify and hold harmless the Board, the Pennsylvania Department of Revenue, the Pennsylvania State Police, the Commonwealth of Pennsylvania and its instrumentalities, and their agents, employees and representatives (collectively the "Indemnitees"), from and against certain enumerated claims and payments.

  - D. Any disclosure or publication in any manner, other than willfully unlawful disclosure or publication, of material or information acquired during any past, present or future investigation of the applicant or Certified Gaming Service Provider.
- 2. Indemnitor will be responsible for and will protect, indemnify and hold harmless the Indemnitees from and against, any and all claims or payments for personal injury, property damage or other loss of any kind by any and all parties and claimants, arising out of, or in connection with, any act or omission by Indemnitor, or any of its principals, key employees, permittees, registrants, affiliated entities required to be certified in Pennsylvania, representatives and agents, where 42 Pa.C.S., Part VII, Ch. 85, Subchapter B (relating to sovereign immunity), is alleged or determined to authorize liability on the part of the Indemnitees.
