2. YOU MUST MAKE ACCURATE STATEMENTS AND INCLUDE ALL FACTS. ANY MISREPRESENTATION, FALSIFICATION OR OMISSION MAY BE SUBJECT TO CRIMINAL PENALTIES UNDER 18 PA C.S.A. §§ 4902, 4903, AND 4904.
3. IF YOU MAKE ANY MODIFICATION TO THE PRE-PRINTED QUESTIONS OR INFORMATION CONTAINED IN THIS FORM, YOUR FORM WILL BE REJECTED. ONCE YOUR FORM IS SUBMITTED, IT BECOMES THE PROPERTY OF THE BOARD AND WILL NOT BE RETURNED.

- The applicant affirms that none of its owners, managers, supervisory personnel, and employees will have any other interest in or involvement with a manufacturer of slot machines, table games, table game devices, interactive games, sports wagering devices, video gaming terminals and all associated equipment or gaming related gaming service provider that could cause the private testing and certification facility to act in a manner that is not impartial.
